I was told by Mr. Sfondrini (the blacksmith) that, according to Italian laws, in order to apply the VAT exemption the invoice must be issued once the works are shipped. He will be able to send you the invoice (and not the proforma invoice) only after the exhibition. Until that moment it is as the installation was given by Mr. Sfondrini, producer of the work, to Viafarini "in vision" (like a showroom).
