Because I would like to give an answer to people we spoke with that night, together with Anna, about a purchase, I summarise as following to be sure that everything is clear:

- small bird, edition of 3: Euro 1,200
- small tower, edition of 3: Euro 2.500
- commission of something similar to lion, big bird, big tower (not too many: two pieces for collector Tullio Leggeri who agreed with Daneri, Galtarossa and me that night to acquire a similar lion and a similar big bird together with a tower. I hope he will like the edition of the tower).

There is also another very good collector, Gemma Testa, that waits to know the price and Anna Galtarossa hopes that she can follow her work, also.

About the prices for commissions: I was thinking over the prices we mentioned and honestly I would suggest a price of Euro 8.000 for similar lion and Euro 6.000 for big bird, especially for Mr. Leggeri who wants three pieces and follows the work of Anna, and for Gemma Testa; they both have important collections.

Dear Patrizia.

I have attached a copy of the consignment agreement for Anna Galtraossa's installation, Kamchatka, as well as the two editions you and Spencer spoke of: Bird, and Skyscraper.

I will also fax this to you, and if you could please fax and send me a hard copy of the agreement that would be great.

As we had agreed, we gave you a special high commission for the sale of Kamchatka because it is a large installation, and we know the difficulty and work involved in selling a piece of that caliber. For that reason, we also made two smaller works available for you to sell so that you can accommodate your collectors who might not have the space or budget for such a piece. However, anything outside of these works would need to be dealt with on an individual basis and would require a separate consignment. I discussed this with Spencer, and he is fine with 8,000 EURO for the Lion and 6,000 EURO for the Bird. If there is interest in a commission of the Large Tower (skyscraper) then we will need more information regarding the size in order to set a price. Please be sure to understand however, that all of these pieces would be slightly different since the original pieces must remain part of Kamchatka. We would produce new pieces of the Bird, the Lion, and the Skyscraper, which would be similar but not exactly the same. As well a separate consignment will have to be made for these pieces and would be our standard contract with galleries, reimbursing the production costs off the top and splitting the remainder equally.

I hope that this letter finds you well, and that you are enjoying your Holiday Season. I look forward to hearing from you, and to our continued promotion of Anna's work together.
