




In addition to the content of the loan agreement, the following conditions apply and must be heeded in full:

**1. Release of works**

The loans will only be released for shipping once the signed loan contract has been received and full payment of the insurance premium has been effected.

**2. Condition Reports**

A condition report will be made at the exhibition site before installation and de-installation. It shall specify all changes that have occurred over the course of the loan period. Should any damage be observed during the loan period, the borrower shall immediately alert the lender, who will decide on the appropriate course of action at his discretion. This might include the withdrawal of the works for the remaining term of the exhibition period, if deemed necessary.

In case of damage, the lender or his representative shall examine the condition of the works. The borrower acknowledges the assessments and appraisals that have been made by countersigning the condition report. The borrower must grant the lender or his representative full access to the displayed works at any time.

**3. Packing**

The works must be packed appropriately. All costs for crating and packing will be charged to the borrower. After termination of the loan period, the packing shall remain the property of the lender.

**4. Transportation**

Transportation of the loan to the exhibition site is to be handled by a fine arts shipper specified or approved by the lender. Road transport must be carried out by an air-conditioned truck equipped with air suspension. The works shall not be touched during transportation. Empty crates and other packing material must be safely stored at an appropriate location.

**5. Handling, installation and de-installation of the art works**

Unpacking and packing as well as storage of the works may only be carried out at the exhibition site. Any handling of the works, such as loading and unloading, unpacking and installation, de-installation and repacking of the works, may only be performed at the exhibition site by specially trained personnel. The borrower recognizes that protection from damage is the lender's uppermost concern and that it is necessary to exercise the greatest care in dealing with the works.

Smoking is strictly forbidden in both the exhibition and storage areas.

Without the written consent of the lender, the loans may not be taken out of their frames, restored or photographed.

**6. Protection against third Parties**

The borrower guarantees that he is equipped with the most advanced and efficient conservation controls and that he will exercise the best possible protection of the art works.

**7. Liability**

The borrower is liable for any damage, vandalism or loss of the works that occurs during the loan period. He is also liable for intentional and negligent acts, even when not directly at fault. The borrower is also liable for damages that occurred during the loan period but were discovered only after restitution.

The works must be insured against all risks on behalf of the lender for the cited insurance value by an insurance company approved by the lender. Insurance is to cover the entire loan period nail-to-nail.

**9. Costs**

The borrower shall cover all costs and expenses incurred in connection with the loan, such as the cost of conservational and technical inspection and corresponding treatment, packing costs for the dispatch from and return to the lender, costs for any required transport escort (including travel, accommodation and per diem expenses) and transportation costs.

**10. Documentation and Reproduction**

For his archives, the lender shall be provided free of charge with three copies of the exhibition catalogue.

The borrower shall also provide the lender with good-quality photographs of the installation. Reproduction of the works for documentation and educational purposes is allowed. Reproduction for commercial purposes is prohibited.

**11. Notice for Termination**

The lender has the right to terminate the lending period for eminent reasons without prior notice. In particular, such eminent reasons include any breach by the borrower of agreements stipulated in this contract as well as any non-professional handling of the works.

**12. Governing Law**

This agreement shall be construed under and governed by Swiss Law, especially section 305 et seq. of the Swiss Code of Obligation relating to contracts for loan of an object for use. Any disputes arising with respect to the loan and the loan conditions that cannot be settled amicably and satisfactorily by mutual agreement will be subject to the exclusive jurisdiction of the competent court in Zurich.

**Miscellaneous**

The loan may not be transferred to a third party or exhibited or deposited elsewhere without the written consent of the lender. After the conclusion of the exhibition, the loans shall be promptly returned to the lender.

This agreement is concluded to the full mutual agreement of the two parties. It shall not be amended or otherwise modified except by express written agreement between the lender and the borrower.

Ocean




