**To whom it may concern**

### **> place. order.hanging etc.**

"minuteman" should be put on the wall in the height of the average mans eyes in the order of 1 , 2 , 3 {on the back of tableauxs there are numbers 1,2,3 soldates} then text and title as you put it for the other works.

\_all tableauxs and additional text must be installed on one wall.\_Distance between each depends from the place y put it on , but it should be approx. 12 to 15 cm or size proportional to whole setup.

\_about hanging: sticking to the wall or battened with the nail if it is ok {rusty nail if you find it, few cm above the photograph}

\_idea was to put glass above the tableauxs but due to transportation it was not possible.

### **> lighting**

if it is possible give an accent with light to photographs rather then the complete tableauxs cause black surface is not so good and neat

[ I don't know lighting constelation in viafarini, also I am not familiar with this space so thats reason these instructions are not so proper, maybe ]

### **> text and title of the work**

if it is possible print text on tracing {cristallo} paper, A4 format,  
with the given font in which texts are already
