Dear Milovan,

I received your feedback about 'Loss' and discussed it with Stijn and Hans:

At first we would like to say that we aren't in the habit of an exchange of a drawing for a production of an installation. However, we realise that the installation we want to make is a bit more complicated than the one you have seen in Miami.

I made some calculation about productioncost. Like you said, the only cost will be that of the material. The actually construction will be sponsored. The amount I estimated is that of the wood (60x mdf panels (3mm), 180x beams 36X36X240) the paint and screws: 2000euro (that is without the rent or purchase of the projection and sound installation).

A drawing costs 5000euro. So there will be a lot of profit for the director. Because of the favor we will do when we agree with the deal, we want to have a perfect installation. The installation should therefore be well made, that is professional quality. And we want to use it again.

Because of this profit and the aim for good quality, we can only agree with the deal, under a few conditions:

- 1. The construction of the installation should be finished by the 8th of January 2006, so that the assembling can start on the 9th.
2. I (Kurt) will come over the 4th of January: to make sure that the installation is well made and to help with sculptural aspects.
3. For the assembling I need two assistants (the guys you mentioned before sound okay).
4. I need to be able to work after the official working hours (for instance until 22:00 or 23:00) both in the VIAFARINI as in the studio where the installation will be made.
5. The transport of the installation (Milano-Brussels) will be paid by (the director of) the VIAFARINI or by sponsorship.
6. A per diem of 25euro each day that I (Kurt) stay in Milano. This goes as well for the visit and staying of Hans.
7. There should be transport facilities (bus, subway,?) between the studio where the installation is built, the VIAFARINI and my accommodation. (transport will be paid with the per diem!)

If you agree with these conditions, the construction can start as from today.

I only have to make a drawing which concerns the floor coverage: Wood in the projection space and carpet in the space where the people can sit.

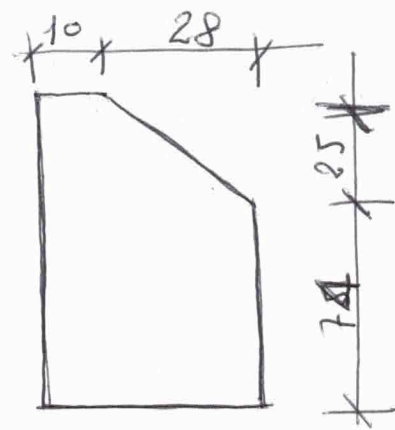
I forward to you your confirmation of booking for the flight, which you will need to collect your ticket.

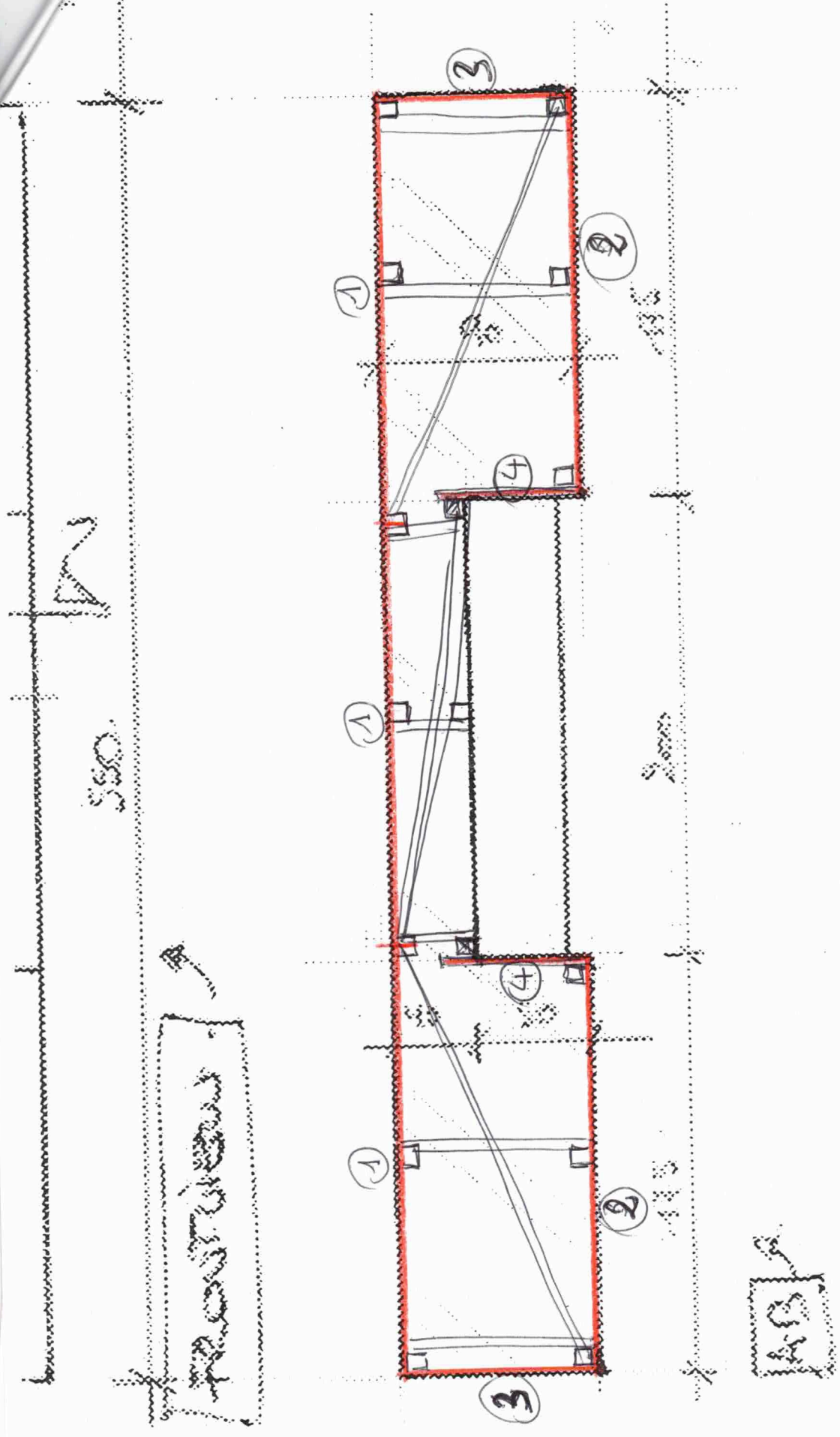
