Dear Signor Ronco

My name is Simone LeAmon, I am an Australian artist and designer currently exhibiting work in Milan at Association Viafarini and Careof contemporary art spaces as part of the exhibition **Quiet Collision: Current practice Australian style.**

Please accept the accompanying catalogue to the exhibition and my solo catalogue **MOTO Showroom**, which features designs for a female's motorcycle racing leather and helmet. This work was first presented in Melbourne this year at *Gertrude Contemporary Art Spaces* and at the *Australian Motorcycle Grand Prix* at Phillip Island at which I was artist-in-residence.

The suit exists as a three-dimensional, computer-generated model. Exhibited in Milan are five large digital prints at a scale resembling my height and space. Accompanying the prints is a Ducati 999, courtesy of Ducati Bologna. The suit also features in the 3-minute animation titled 'Heartland' in which the chick-racer along with her Ducati transform the landscape they inhabit.

Prior to leaving Milan for Australia on 1 December I hope that it is possible to come and speak to you. I am interested to know what is involved and if it would be possible to have this or a similar suit made by Dainese in the future. Apart from showing this work to Ducati I have not had an opportunity to discuss the project with industry, if you were available to meet with me in the following weeks I am happy to come to Molvena.

I can be contacted while in Milan through Association Viafarini. The director Patrizia Brusarosco and gallery administrator Monica Lotta are happy to facilitate correspondence. However I look forward to speaking with you and hope that you find the accompanying catalogues of interest.
